

INVITATION FOR BIDS



Unit Muridke District Council Sheikhupura

(Procurement of Solid Waste Machinery & Equipment and Fabrication of Superstructures on Chassis of Vehicles for Muridke City)

1. The Government of Pakistan has received a loan (Credit No. 6243-PK) from the International Development Association (IDA) for funding of Punjab Cities Program (PCP) and intends to use part of the funds to cover eligible payments under the contract for sub-project "Provision of Machinery & Equipment for Improvement of Solid Waste Management in Muridke City" The Program will be implemented under the control of Punjab Municipal Development Fund Company (PMDFC).
2. Unit Muridke District Council Sheikhupura also wants to purchase the equipment as given in the Table-1 below.

3. Unit Muridke District Council Sheikhupura intends to invite eligible Vendors/Manufacturers having expertise in the above mentioned fields for procurement of the following Machinery / Equipment.
4. The Bidder must:
 - (i) Be a registered body duly recognizable under the law of Pakistan
 - (ii) Be registered with FBR for income Tax and Sales Tax.
 - (iii) Not be blacklisted.
 - (iv) Not be involved in litigation with any Government Department, Agency/Organization etc.
 - (v) Have sufficient financial, technical and human resources to complete the procurement within prescribed time limit on the finalization of contract.
5. Bidding Documents will be available immediately after publication of this notice and can be purchased from Office of Chief Officer, Unit Muridke District Council Sheikhupura for a non-refundable fee of Rs. 5000/- for each set. Interested bidders may obtain further information from the same address.
6. Bids shall be valid for a period of 90-days after Bid opening and must be accompanied by bid security of amount Rs.134,000/- (Bid Security is in line with PPRA Rule-27) in the form of a Bank Draft or an irrevocable encashable on-demand Bank Call Deposit or Bank Guarantee from any schedule Bank of Pakistan in favor of Chief Officer Unit Muridke District Council Sheikhupura and shall be delivered on or before **16-05-2022 at 12:00 PM**. The bids shall be opened in the presence of the bidders or their authorized representatives who choose to attend at **12:30 PM** on the same day at the above given office.
7. A pre-bid meeting with contractors will be held on **11-05-2022** in the office of Chief Officer, Unit Muridke District Council Sheikhupura and interested bidders are invited for participation.
8. Last date of collecting the bidding documents is **14-05-2022**.
9. The Bidding Procedure will be governed by Rule 38(2)a of PPRA, 2014 "Single Stage Two Envelopes" procedure. The bids shall be evaluated on the basis of qualification criteria provided in the bidding documents.
10. Unit Muridke District Council Sheikhupura reserves the right to cancel/reject all offers, as per Punjab Procurement Regulatory Authority (PPRA) Rules (2014).
